Umpires Contract

League will contact the BUA as Jon Adams is looking for an increase in assigner fees from \$60 to \$65. The umpire fee would increase aby a \$1. For 4/5 and 6/7 at \$47 per game and higher levels of \$41 per game per team if 2 umpires, and \$53 (\$26.50 per team) if only one umpire. BUA would have lower assigner fees, but higher umpire fees. Probably a wash to the organization (but would result in keeping league fees lower per team, and higher umpire fees paid by organization.)

Budget for 2017 will be presented at January Meeting: Notes from January 2015 meeting that we raised per team league fee from \$85 to \$90 in 2016 season, but noting a potential \$95 per team league fee. This is partially dependent on Umpire Fees for 2017 season and how we manage cost like internal umpires for 2/3 advanced level.
