### **New Rules**

## 2/3 ADVANCED LEVEL

- Baserunning
  - ADD #8 A 2/3's line shall be placed vertically 18 feet 4 inches before Home Plate, third base and second base, The line shall be 2 feet long and 2 inches wide. This will allow the umpire to better determine where the runners shall be placed.

### • 4/5 LEVEL

- General Rules 4,a,1
  - ADD A 2/3's line shall be placed vertically 18 feet 4 inches before Home Plate, third base and second base. The line shall be 2 feet long and 2 inches wide. This will allow the umpire to better determine where the runners shall be placed.
- Batting 5 and 6
  - CHANGE #5 to: The ninth batter will maintain a regular pitching count. Should the batter have four balls thrown to her she will walk and the inning shall be completed. A pitched ball may not be rolled into the plate intentionally.
  - **DELETE #6** It will no longer be necessary to throw one strike to the 9<sup>th</sup>. batter. She may be walked.
- Baserunning 7,d.
  - ADD The defensive team may retire the batter/runner using only the white base when the ball is thrown in the inside of the baseline in fair territory. In the event the ball is thrown outside of fair territory the yellow/red (Safety) base may be used.
- o Baserunning 9-A
  - Proposal to change the number of steals from 8 to 6 was reject by org reps.
- Baserunning 4,a,4
  - "In the event of a force play the runner may go to the base but may not go any further." CHANGE - In the event of a force play the runners may advance one base at their own risk on an overthrow. In the event of a non-force play the runners may not advance on an overthrow.
- Baserunning 4,a,5
  - ADD No advancement may take place on a return throw from the catcher to the pitcher.
- o Baserunning 12

 ADD NEW DEFINITION – One base will be allowed on a base on balls. Once the runner has touched first base play shall be declared dead. [no give me play of walk and running to second base]

### • 8/9 LEVEL

- o Complete Games 4,2
  - **CHANGE TO:** In the event the home team is leading by 10 runs after four and one half innings or the visiting team is leading by five (5) innings.
  - 6,c,8 CHANGE 5 Pitching appearances to 35 innings.
